## ORDINANCE NO, 4 - 1985

AN ORDINANCE AMENDING ORDINANCE NO. 2 OF 1962 LIMITING GROSS WEIGHT OF MOTOR VEHICLES ON CERTAIN ROADS IN FRANKLIN TOWNSHIP BY ACKNOW- THE NAMING AND IDENTIFICATION OF SAID ROADS AND AMENDING AND REVISING THE PENALTIES AS SET FORTH IN SAID ORDINANCE.

Sections 3 and 6 of Ordinance No. 2 - 1962 are amended to read as follows:

- a). Township Road #870, Hickory Road, from Route #15 North one and six-tenths (1.6) miles to State Legislative Route #66001, mountain Road;
- b). Township Road #882 (formerly #873), Coffeetown Road, from State Legislative Route #66001, Mountain Road, Southwest one and six-tenths (1.6) miles to Township Road #874, Whiskey Springs Road;
- c). Township Road #874, Whiskey Springs Road, South four-tenths (A) of a mile from its connection with Township Road #882 (formerly #873), Coffeetown Road, to the plank bridge;
- d). Township Road #858 (formerly #867), Central View Road, from U.S. Route #15, six-tenths (.6) of a mile West to Township Road #870, Hickory Road;
- e). Township Road #850 (formerly #881), Glenwood Road, one and three-tenths (1.3) miles East from Route #15 to Legislative Route #66023, Cabin Hollow Road:
- f). Township Road #880, By Pass Road, from State Legislative Route #194, three-tenths (.3) of a mile parallel with State Road #194 to Legislative Route #194;
- g). Township Road #993, Mill Road, three-tenths (.3) of a mile from Route #15 East to Legislative Route #66022, Franklin Church Road;
- h). Township Road #887 (formerly #859), Barrens Church Road, beginning at the Franklintown Borough limits, thence east five-tenths (.5) of a mile to the Washington Township line;
- i). Township Road #860, Willow Glen Road, five-tenths (.5) of amile East from Legislative Route #66022, Franklin Church Road, to the plank bridge;
- j). Township Road #877, Water Street, from Township Road #870, Hickory Road, one (1) mile West to Township Road #867, Union Church Road;
- k). Township Road #876 (formerly #871), Harmony Bethel Road, three-tenths (.3) of a mile South from Legislative Route #66001, Mountain Road, to the Harmony Bethel Church.
- 1). Township Road 4869, Spring Drive, from Legislative Route #66022, Clear Springs Road, to Township Road #868, Chestnut Hill Road, and Township Road #883 (formerly #869), Lake Lea Drive, from Legislative Route #66022, Clear Springs Road, to Township Road #877, Water Street, a total of seven-tenths (.7) of a mile.

 $\underline{Section} \ \ 6: \ Any \ person \ who \ shall \ violate \ this \ ordinance \ or \ any \ provisions \ of \ this \ ordinance \ shall, \ upon \ summary \ conviction \ before \ a \ Magistrate \ or \ District justice \ of \ the \ Peace, \ be \ sentenced \ to \ pay \ a \ fine \ of \ no \ less \ than \ $50.00 \ and \ no \ more \ than \ $300.00 \ together \ with \ costs \ of \ prosecution, \ and, \ in \ default \ of \ payment \ thereof, \ shall \ undergo \ imprisonment \ for \ not \ more \ than \ thirty \ (30) \ days.$
