## ORDINANCE NO. 2 - 1995

AN ORDINANCE AMENDING ORDINANCE NO. 2 OF 1962 AND ORDINANCE NO. 4 OF 1985 LIMITING GROSS WEIGHT OF MOTOR VEHICLES ON CERTAIN ROADS IN FRANKLIN TOWNSHIP BY ACKNOWLEDGING, NAMING AND IDENTIFICATION OF SAID ROADS IN SAID ORDINANCES AND REVISING AND ADDING CERTAIN ROADS TO SAID ORDINANCE BY THIS AMENDMENT AND REVISING THE PENALTIES AS SET FORTH IN ORDINANCE NO. 4 OF 1985.

Section 3 and 6 of ordinance No. 4 of 1985 are amended to read as follows:

Section 3: The weight limitations of twenty two thousand (22,000) pounds shall apply to the following Township roads:

- a). Township Road # 870, Hickory Road, from Route #15 North one and six-tenths (1.6) miles to State Road SR 4040, South Mountain Road;
- b). Township Road # 882, Coffeetown Road, from State Road SR 4040, South Mountain Road, Southwest one and six-tenths (1.6) miles to Township Road # 874, Whiskey Springs Road;
- c). Township Road # 8749 Whiskey Springs Road, South four-tenths (.4) of a mile from its connection with Township Road #882, Coffeetown Road, to Township Road # 642, County Line Road;
- d). Township Road 858, Central View Road, from Township Road # 870, Hickory Road, sixty two hundredths (.62) of a mile to Township Road # 867, Union Church Road;
- e). Township Road # 8509 Glenwood Road, one and threetenths (1.3) miles East from Route #15 to SR 40369 Cabin Hollow Road;
- f). Township Road # 8809 By Pass Road, from State Legislative Route # 194, three-tenths (.3) of a mile parallel with State Road # 194 to Legislative Route # 194;
- g). Township Road # 993, Mill Drive, three-tenths (.3) of a mile from Township Road #852, Capitol Hill Road, to State Road SR 40439 Franklin Church Road;
- h). Township Road # 887, Barrens Church Road, beginning at the Franklintown Borough limits, thence east five-tenths (.5) of a mile to the Washington Township line;
- i). Township Road # 860, Willow Glen Road, five-tenths (.5) of a mile East from State Road SR 40439 Franklin Church Road, to Township Road # 853, Franklintown Road.
- J). Township Road # 877, Water Street, from Township Road # 870, Hickory Road, one (1) mile West to Township road # 867, Union Church Road.
- k). Township Road # 876, Harmony Bethel Road, eightyone hundredths (.81) of a mile from State Road SR-4040, South Mountain Road, to Township Road 873, Circle Drive
- 1). Township Road # 869, Spring Drive , Ninety nine hundredths (.99) from State Road SR-4038, Clear Springs Road, to Township Road# 642, County Line Road.

- m). Township Road # 8839 Lake Lea Drive, thirty seven hundredths (.37) miles from State Road SR 4038, Clear Springs Road to Township Road # 877, Water Street.
- n). Township Road # 891, Tuckahoe Road, from Township Road # 881, West Greenhouse Road, West to the Cumberland County/York County line, a total of one (1.0) mile.
- o). Township Road #642, County Line Road, from the Cumberland County Line to the end of the Franklin Township maintenance area Northwest of Township Road # 869, Spring Drive, a total of two and sixty nine hundredths (2.69) miles.
- p.) Township Road # 867, Union Church Road, from State Road SR 4040, South Mountain Road, to State Road SR 4038, Clear Springs Road, a total of one and thirteen hundredths (1.13) miles.
- q). Township Road # 884, Stony Run Road, from State Road 0194, Baltimore Road, to the Carroll Township/Franklin Township line, a total of two tenths (.2) mile.
- r). Township Road # 886, Locust Grove Road, from Township Road # 853, Franklintown Road, to the Washington Township/Franklin Township line, a total of one and one hundredths (1.01) mile.
- s). Township Road # 853, Franklintown Road, from Township Road # 852, Capitol Hill Road, to State Road 0194, a total of three and twenty four hundredths (3.25) miles.
- t). Township Road # 856, Lost Hollow Road, from Township Road # 853, Franklintown Road, to State Road SR 4043, Franklin Church Road, a total of one and sixty five hundredths (1.65) miles.
- u). Township Road 0873, Circle Drive, from State Road SR 4038, Clear Springs Road, to State Road SR 4038, Clear Springs Road, a total of seventy eight hundredths (.78) mile.
- v). Township Road # 881, West Greenhouse Road, from State Road SR 4040, South Mountain Road, to Township Road # 891, Tuckahoe Road, a total of seventy six hundredths (.76) mile.
- w). Township Road # 888, Clear View Road, from State Road SR 4036, Old Cabin Hollow Road, to State Road SR 4043, Franklin Church Road, a total of seventy one hundredths (.71) mile.
- x). Township Road # 863, Ridge Drive, from Township Road 642, County Line Road, to Township Road #861, Big Dam Road, a total of ninety four (.94) hundredths mile.
- y). Township Road # 865, Scotch Pine Road, from Township Road 0 642, County Line Road, to Township Road # 852, Capitol Hill Road, a total of one and twenty five hundredths (1.25) miles.
- z). Township Road 0 872, Stone Head Road, from Township Road # 642, County Line Road, to Township Road # 882, Coffeetown Road, a total of eighty six hundredths (.86) mile.

Section 6: The above restriction shall not apply to local traffic. Local traffic is defined as the following:

- a) Emergency Vehicles
- b) School Buses
- c) Vehicles and combinations of government agencies, utilities and/or contractors engaged in construction or maintenance on a posted roadway or in a location which may be reached only via a posted roadway; and
- d) Vehicles and combinations going or coming from a commercial establishment, personal residence or a farm located on a posted roadway or which can be reached only via a posted roadway.

Upon determination by the Township that local traffic is likely to damage roadways subject to these restrictions, local traffic will be banned from using those roadways. See  $67\ Pa.\ Code\ 189.3(b)$ .

Section 7: Any person who shall violate this Ordinance or any provisions of this Ordinance shall, upon summary conviction before a Magistrate or District Justice of the Peace, be sentenced to pay a fine of no less than \$300.00 and no more than \$1,000.00 together with costs of prosecution, and, in default of payment thereof, shall undergo imprisonment for not more than thirty (30) days. These fines shall not supersede the fines authorized by the Pa. Vehicle Code, and it is the intention of the township that the penalty shall be the greater of the penalties set forth in this section or those established by the Pa. Vehicle Code.
