AN ORDINANCE AMENDING THE FRANKLIN TOWNSHIP ZONING ORDINANCE (ORDINANCE NO. 2006-1), ARTICLE 4 "SPECIFIC CRITERIA", SECTION 435 "JUNKYARDS" REGARDING SPECIAL EXCEPTION CRITERIA FOR JUNKYARDS

**BE IT ENACTED AND ORDAINED** by the Board of Supervisors in and for the Township of Franklin, York County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

1. The Franklin Township Zoning Ordinance, Article 4 "Specific Criteria", Section 435 "Junkyards" is hereby amended by substitution to read as follows:

## § 435 Junkyards.

- A. Standards are set forth in Franklin Township Ordinance No. 7 of 2009, adopted September 14, 2009, relating to licensing of junk dealers and junkyards.
- 2. If any sentence, clause, phrase or section of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, phrases, sections or parts of this Ordinance. It is hereby declared as the intention of the Board of Supervisors of this Township that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, phrase, section or part thereof not been included therein.
- 3. Any other Ordinance or Resolution or parts thereof inconsistent with this Ordinance be and area hereby expressly repealed.

- 3. Any other Ordinance or Resolution or parts thereof inconsistent with this Ordinance be and area hereby expressly repealed.
- 4. This Ordinance shall be effective at 12:01 A.M. on the  $6^{th}$  day following the adoption hereof by the Board of Supervisors of the Township of Franklin.
